- 2 The Monduli District Council now invites sealed bids from all eligible Civil Contractors registered in Class IV and above to carry out **Water Supply Scheme at Mti Mmoja and Nanja Village in Monduli District Council**

- 3 Bidding will be conducted through the National Competitive Bidding procedures specified in the Public Procurement (Goods, Works, Non Consultant Service and Disposal of Public Assets by Tender) Regulations, 2013 - Government Notice No. 446 and its amendment of 2016 and are open to all eligible Bidders as defined in the Regulations.
